A LETTER FROM THE PRESIDENT

Asalaamu Alaikum. Peace be with you.

Martin Luther King, Jr. said: *"The ultimate measure of a man is not where he stands in moments of comfort and convenience, but where he stands at times of challenge and controversy."* Our speakers tonight are American Muslims who stand strong for truth and justice.

CAIR-MN functions on a basic premise: That everyone deserves to be treated with respect and dignity. This includes Muslim employees in St. Cloud who were denied legal rights in the workplace; the Jewish student who failed a college exam because of a religious holiday; the minority high school students who were physically assaulted on a regular basis; the Somali who was told to remove her headscarf in order to continue with her job interview; or the Muslim family detained at the airport and asked questions such as, "How many times do you pray?"

CAIR-MN is not a typical 5-year-old organization. A typical 5-year-old organization does not get quoted in the media over 100 times each year; or successfully challenge and end discriminatory practices and policies. It does not get invited to speak at state-wide conferences and provide trainings to major corporations or win the prestigious Mission & Excellence Nonprofit Award. "For every day on which the sun rises, there is a reward from God for those who establish justice among people." -Prophet Muhammad (peace be upon him).

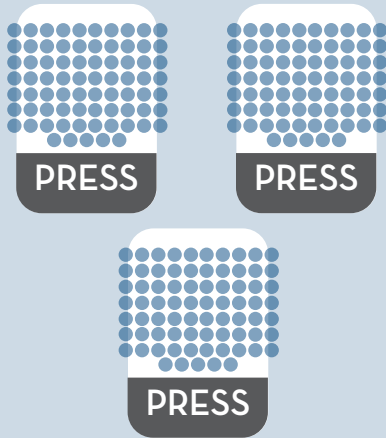
Thank you for joining us as we honor our inspirational heroes, reflect on our past endeavors and embrace a promising future.

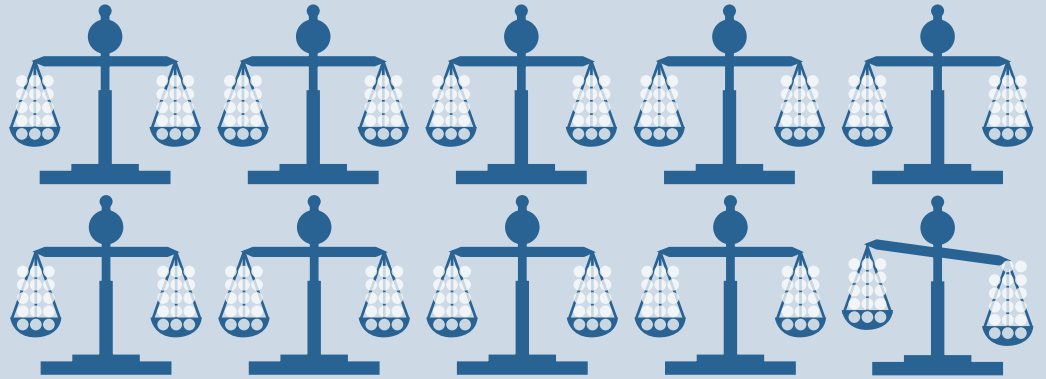

3 MEDIA TRAININGS WITH 75 ATTENDEES



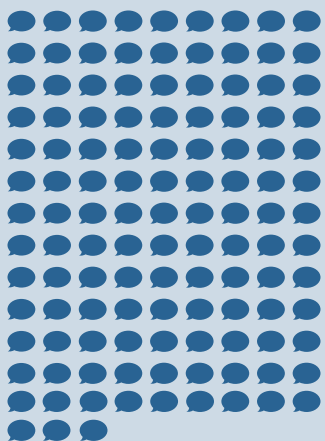
10 KNOW YOUR RIGHTS TRAININGS WITH 302 ATTENDEES



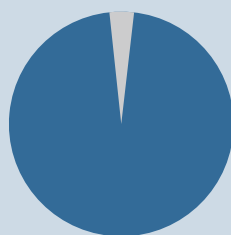
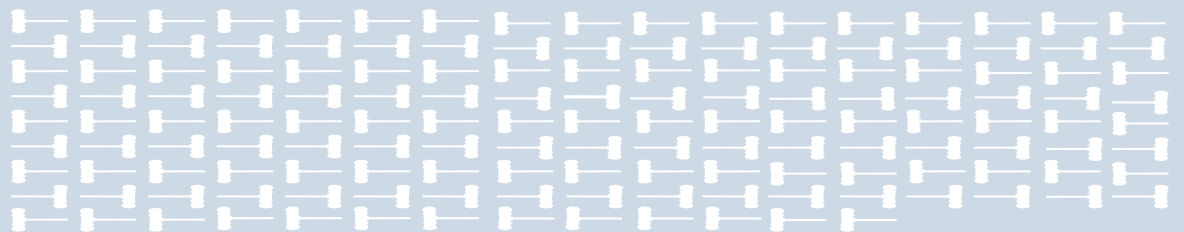
17 DIVERSITY TRAININGS WITH 609 ATTENDEES

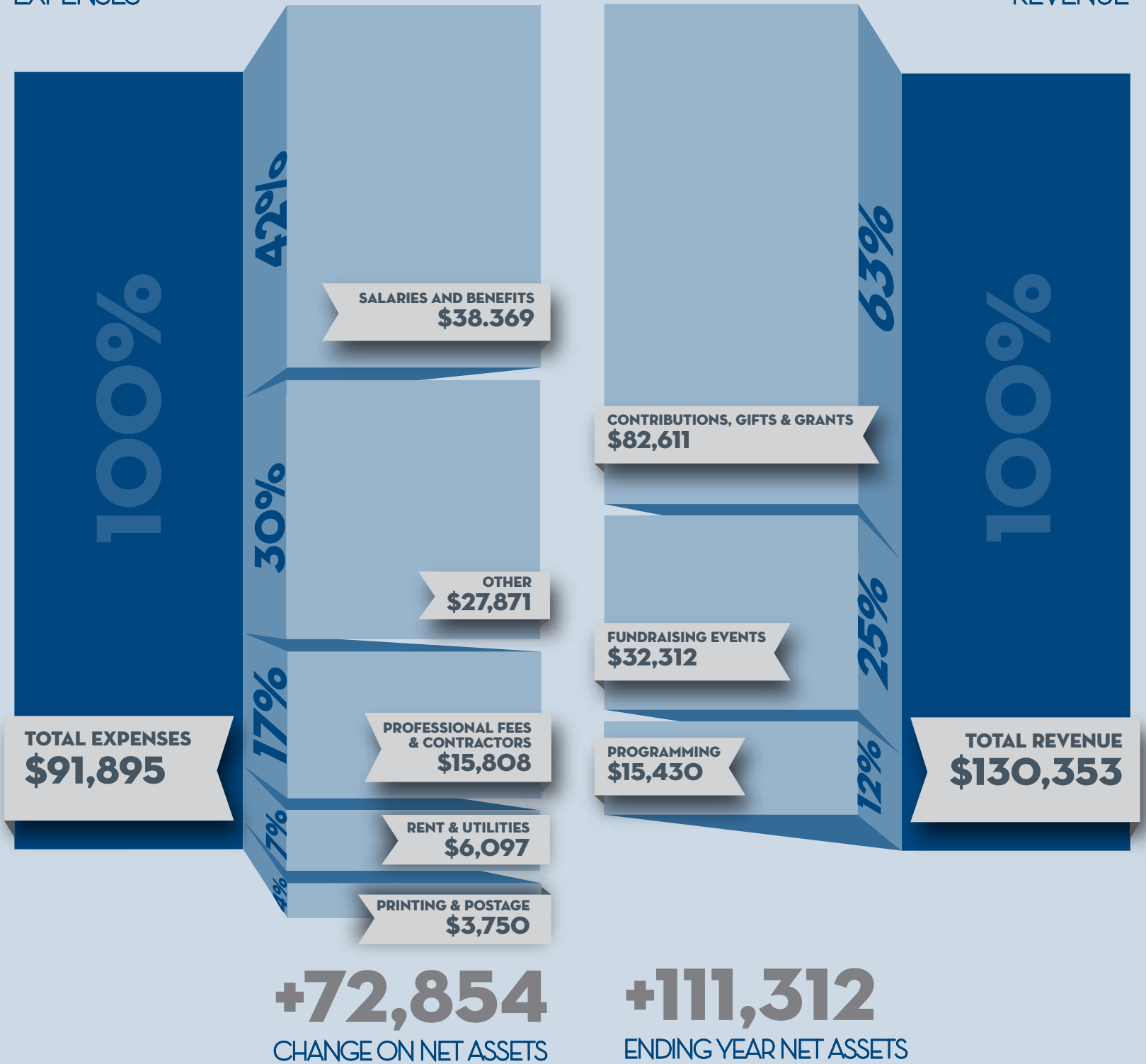
